## GENERAL INFORMATION

Accepted abstracts may be shortlisted for **Oral Presentation** or exhibited as **e-Posters** on digital display at the International Myopia Society Meeting in Singapore on the 19 July 2025.

## ABSTRACT GUIDELINES

**Abstracts should be submitted under the topic of Myopia** with focus on either: Prevention, Diagnostic, Imaging, Treatment or General Myopia.

All submitted abstracts must be in English and follow the structured format below:

- **Title (250 characters max).** It should be in **BOLD CAPITALS**. Do not centralise.
- **Authors' names** to be listed as follows:
  - Family names in UPPER CASE, followed by given names in Title Case, without using full-stops. – The presenter's name is to be underlined.
  - Authors' institutions, cities and countries should be listed on the next line.
  - The **section headings** should appear in bold.
    - **Purpose (100 words max):** To contain a brief summary and concise goal of the study
    - **Setting/Venue (50 words max)**
    - **Methods (200 words max):** Should include: Descriptions of the inclusion/exclusion criteria, experiments performed, outcome measures, data analysis procedures and statistical analysis procedure.
    - **Results (200 words max):** Should be qualitative data and/or quantitative data with proper statistical information. Figures or tables can be included.
    - **Conclusions (200 words max):** A concise conclusion should be provided based on the evidence presented in the Results section. The Conclusions should address the question/hypothesis stated in the Purpose section.
- In Microsoft Word format – Paper size: A4, Font: 11, Arial
- The Organising Committee reserves the right to amend or change any part of the submission guidelines.

If applicable please clearly list your financial interest in the subject matter or if you receive funds from any mentioned companies.

## FURTHER INSTRUCTIONS

- Presentation titles must not include company names.
- Accepted Posters must not include company logos.
- The summary of results presented must be given in sufficient detail to support the conclusions. The Review Committee will only accept abstracts with final results or conclusions.
- Formulae should, in general, be avoided.
- When using abbreviations or acronyms for the first time, care should be taken to spell them out in full with the abbreviation in parentheses after the full word(s) the first time it appears in the text. The abbreviation should be used alone thereafter.
- The organizer does not take any ownership of the copyright of a presentation.

## REVIEW & EVALUATION

- All submitted abstracts will be reviewed by a panel of Myopia experts before a final selection is made.
- The decision of the Review Committee is final.
- If your abstract is accepted for Oral presentation or e-Poster, you will be informed of this by email by the **mid of June, 2025**.

- The abstract submission portal will **close on Friday 30 May 2025 (23:59 SGT)**.
